Harry G. Broadman is a veteran multinational corporate finance, enterprise restructuring, and business growth strategy operating executive and a non-executive corporate director.

Broadman's 38-plus year career is marked by deep operational expertise across **financial services, private equity, and investment banking; emerging and advanced technology industries; infrastructure, logistics and utilities; and energy, minerals and natural resources.**

He is worldwide renowned practitioner and authority on C-suite decision-making and board oversight of business operations that capitalize on new market opportunities and mitigate risks in order to attain competitive advantage by **structuring and financing innovative cross-border investment transactions, M&A, and JVs; agile management of global supply chains; executing robust corporate governance, compliance and cybersecurity practices; proactively investing in applied R&D and intellectual property; adeptly navigating national and international regulatory regimes; and judicious implementation of CSR and ESG initiatives.**

His professional experience is uniquely geographically expansive: **he has worked in all the advanced countries and in 85+ emerging markets across 5 continents**, including China/East Asia, Russia/CIS, Turkey/The Balkans, Eastern and Central Europe, India/South Asia, LATAM, the Middle East and Africa.

In 2020, Broadman joined Berkeley Research Group LLC (BRG), where he is a partner and chairs the firm's emerging markets transactions practice. He is an **independent director on several corporate boards; a National Association of Corporate Directors (NACD) Board Leadership Fellow and an NACD-commissioned faculty for its Board Advisory Services**. He is also on Johns Hopkins University's faculty.

At BRG, he both serves as an **expert witness in international arbitration and litigation on global investment, antitrust and intellectual property disputes and counsels C-suites and boards of U.S. and non-U.S. corporations, private equity firms, banks, institutional investors, and sovereign wealth funds**. Prior to BRG, he was the CEO of Proa Global Partners, an international investment strategy firm.

In 2015, he stepped down as Senior Managing Director from **PricewaterhouseCoopers**, where he founded and led PwC's Global Business Growth Strategy Practice, which operated in 20+ countries. He also served as PwC's Chief Economist, working closely with PwC's Chairman, CEO, and the leaders of PwC's global audit and tax practices.

Before coming to PwC, Broadman was an **international private equity investment executive** at Albright Capital Management (ACM), the firm chaired by Madeleine Albright, where he served on the investment committee, engaged in capital-raising, and led ACM's proprietary in-house deal flow generation process. Previously, he was a senior executive at The World Bank Group, overseeing the **Bank's largest enterprise restructuring and sovereign loan operations—exceeding \$3 billion**—in China, Russia/CIS, the Balkans, and Africa. He has also held posts at the RAND Corporation and RFF, Inc.

Broadman served in the White House, first as **Chief of Staff of the President's Council of Economic Advisers** and then as **United States Assistant Trade Representative**, where led U.S. negotiations for the establishment of the WTO and NAFTA; of all U.S. Bilateral Investment Treaties; and of all U.S. International Science and Technology Agreements. He also served as a Member of the Committee on Foreign Investment in the U.S. (CFIUS) and on the Board of the Overseas Private Investment Corporation (OPIC). Earlier he was Chief Economist of the **U.S. Senate Homeland Security and Governmental Affairs Committee** (chaired by John Glenn). In addition to Johns Hopkins, he has been on the **faculty of Harvard University** and a fellow at the **Brookings Institution**.
